- (e) Any material change in the present capitalization or dividend policy of the issuer;
- (f) Any other material change in the issuer's business or corporate structure;
- (g) Changes in the issuer's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the issuer by any person;
- (h) Causing a class of securities of the issuer to be delisted from a securities exchange;
- (i) Any action similar to any of those enumerated above.

### Item 4. Interest in Securities of the Issuer

- (a) Jaka Securities Corporation subscribed 42,334,439 common shares at Php 2.40 per share. This is equivalent to 9.5% of the issuer's total outstanding shares of 445,340,679 after the issuance.
- (b) Jaka Securities Corporation has the sole power to vote for the subscribed 42,334,439 common shares.
- (c) There is no transaction in the class of securities reported on by Jaka Securities Corporation for the past sixty (60) days.
- (d) Jaka Securities Corporation has the sole right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of such securities.
